

**COMBINED SYNOPSIS / SOLICITATION
REQUEST FOR QUOTE (RFQ)**

MICROSOFT PREMIER SUPPORT

This is a combined synopsis / solicitation for commercial items prepared in accordance with the format in the Federal Acquisition Regulation (FAR) Subpart 12.6, Streamlines Procedures for Evaluation and Solicitation for Commercial items, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation: quotes are being requested and a written solicitation will not be issued. Anticipated date of award is not later than 30 September 2014.

This (RFQ) and incorporated provisions and clauses are those in effect through Federal Acquisition Circular 2005-76, dated 25 August 2014.

Notice Regarding Any Set-aside

This acquisition is being wholly set-aside for small business per FAR 13.003(b) competing under NAICS code 511210 (Software Publishers), size standard \$38,500,000.00.

Contract Line-Item(s)

1. CLIN 0001 200 hours TAM (Technical Account Manager) to oversee the support contract. The TAM will provide monthly updates to the assigned government POC/s on usage of the contract and hours still available on the contract.
2. CLIN 0002 305 hours of US National support for any support call that will address sensitive settings or information which cannot be discussed with a foreign national.
3. CLIN 0003 Minimum of one on-site visit to ensure the TAM and team understands the goals of the NIAPS program.

Description of Requirements

Microsoft Premier Support – Provided by Microsoft Authorized Resellers of said service. See Attached Statement of Work

Service Location and Period of Performance

Support services will be provided at the Navy Integrated Application Product Suite (NIAPS), located at Naval Surface Warfare Center, Crane, Indiana and related data centers. The bulk of support being telephonic in nature from the Vendor's location.

(d) Comptroller General Examination of Record. (1) The Comptroller General of the United States, or an authorized representative of the Comptroller General, shall have access to and right to examine any of the Contractor's directly pertinent records involving transactions related to this contract.

(2) The Contractor shall make available at its offices at all reasonable times the records, materials, and other evidence for examination, audit, or reproduction, until 3 years after final payment under this contract or for any shorter period specified in FAR Subpart 4.7, Contractor Records Retention, of the other clauses of this contract. If this contract is completely or partially terminated, the records relating to the work terminated shall be made available for 3 years after any resulting final termination settlement. Records relating to appeals under the disputes clause or to litigation or the settlement of claims arising under or relating to this contract shall be made available until such appeals, litigation, or claims are finally resolved.

(3) As used in this clause, records include books, documents, accounting procedures and practices, and other data, regardless of type and regardless of form. This does not require the Contractor to create or maintain any record that the Contractor does not maintain in the ordinary course of business or pursuant to a provision of law.
